Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the Survivor All-Stars Meet & Greet 2019 registration is deemed acceptance of these terms and conditions.

Eligibility to Enter

2. Entry is open to all residents of New South Wales aged 16 years and over, however, employees and the immediate families of Network Ten Pty Limited (the "Promoter") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter.

Registration Period

How to Enter

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. By accepting the Tickets, the Meet & Greet Attendee/s agrees to participate in and co-operate as required with all reasonable media editorial requests relating to the prize, including but not limited to, being interviewed and photographed, filmed and/or chaperoned throughout the duration of the Event.
