Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the “Neighbours 35th Anniversary Screening 2020” registration is deemed acceptance of these terms and conditions.

Eligibility to Enter

2. Entry is open to all residents of Victoria and Western Australia aged 15 years and over, however, employees and the immediate families of Network Ten Pty Limited (the “Promoter”) and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter.

Registration Period

3. The registration commences on **Friday 6 March 2020 at 12:00 AEDT** and closes on **Wednesday 11 March 2020 at 23:59 AEDT** (“Registration Period”) unless allocation is exhausted earlier.

How to Enter

4. To participate in the Registration entrants must:
 - a. Log on to 10play.com.au and register their details including (but not limited to) name, email address and date of birth, to become a 10 Play member.
 - b. Register their details at the Neighbours 35th Anniversary Screening 2020 (“Event”) form.
 - c. Select either the Perth or Melbourne event when registering their details.
5. It is free to become a 10 play member, however, the cost of accessing the promotional website is dependent on the entrant’s individual service provider. These Terms and Conditions apply in conjunction with the 10 Member rules.
6. Incomprehensible and incomplete entries will be deemed invalid.
7. A limit of one online entry during the registration period per 10 play member applies.
8. Registration must be received by Wednesday 11 March at 23:59 AEDT unless allocation is exhausted earlier. Each valid entry received over the duration of the Registration Period will receive entry into the Event.
9. The time of registration will in each case be the time the online registration is received by the Promoter’s database. The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.
10. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Error and omissions will be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

11. All participants hereby permit to have their image and/or voice, as recorded, photographed or filmed during the meet and greet to appear in connection with Network 10 or the advertising or marketing thereof, in any media whatsoever through the world and the Prize Meet & Greet Attendees will not be entitled to any fee for such use.
12. Tickets will be allocated to the first valid entrants
 - a. Melbourne: 65 valid registrations.
 - b. Perth: 100 valid registrations.

Participants will be notified that their registration is successful and that they will be attending the event via email sent on Thursday 12th March 2020 and within one (1) day of the closing date.
13. An entry that is made on behalf of an entrant by a third party will be invalid.

15. Any ancillary costs associated with attending the Event are not included. These are the responsibility of all Screening Attendees. All participants are required to make their own way to and from the locations specified in clause 14.
16. **Attendees and their companion must check in at Security on entry, and provide their first and lasts name, to secure entry into the Event. Each participant must bring a copy of their confirmation email to the Event. Screening Attendees may be required to provide ID to verify their entry.**
17. Any costs, including associated costs in attending to redeem the prize, are the sole responsibility of the Screening Attendees/s.
18. The Promoter's decision is final, and the Promoter will not enter into correspondence regarding the Registration result.
19. It is a condition of accepting the Tickets attendees must comply with all the conditions of use of the Promoter's requirements.

20. Personal information about the registered participants will be used by the Promoter to the extent necessary for the Event tickets to be confirmed via email and Registered Participants to be allowed access to the Event.
21. If the Attendee/s does not provide proof of meeting the age restriction and other valid entry requirements, the Attendee/s will be denied access to the Event.
22. Tickets to the Event will be awarded to the person named in their Registration.
23. It is a condition of accepting the Tickets that the Attendee/s may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.
24. Should the Attendee/s not meet any of the criteria stated in these terms and conditions to be a valid Attendees they will forfeit all rights to the Tickets.
25. By accepting the Tickets, the Attendee/s agrees to participate in and co-operate as required with all reasonable media editorial requests relating to the prize, including but not limited to, being interviewed and photographed, filmed and/or chaperoned throughout the duration of the Event.
26. If for any reason this Registration is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this Registration, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Registration, subject to government legislation.

If this Registration is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Registration, as appropriate, subject to government legislation.
28. All entries become the property of the Promoter. The Promoter collects personal information about you to enable you to participate in this Registration, but no further use of this information will be made without prior consent.
29. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any Event except for any liability which cannot be excluded by law. The Promoter is not responsible for any incorrect or inaccurate information, either caused by the phone user or for any of the equipment or programming associated with or utilised in this Registration, or for any technical error, or any combination thereof that may occur in the course of the administration of this Registration including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.
