## Studio 10 | Nominate Someone 2020 Competition

Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into Studio 10 Nominate Someone 2020 Competition ("Competition") is deemed acceptance of these terms and conditions.

### **Eligibility to Enter**

2. Entry is open to all residents of Australia aged 18 years and over, however, employees and the immediate families of Network Ten Pty Limited (the "Promoter"), YouFoodz Pty Ltd (ABN72 160 909 893) (the "Prize Supplier") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.

### How to Enter

- 5. To participate in the Competition entrants (Entrant) must:
  - a. Log on to 10Play.com.au and register their details including (but not limited to) name, address, phone number, email address, gender and date of birth, to become a 10Play member.
  - b. Nominate an individual (Nominated Entrant/Winner) to win a prize pack in Clause 21 by supplying their first name, last name, postcode and answer in 100 words or less why the Nominated Entrant/Winner "is doing it tough" and deserving of this prize. In consideration of the Promoter awarding the Major Prize/s to the Nominated Entrant/Winner hereby permits the Nominated Entrant/Winner's image and/or voice, as recorded, photographed or filmed. - 17. Both the Entrant and the Nominated Entrant/Winner must be deemed as valid entrants by providing but not limited to legal first name, legal last name and post code belonging to them. The Promoter or Prize Supplier shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law.
