# Coles | Junior MasterChef Competition Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry Coles | Junior MasterChef Competition ("Competition") is deemed acceptance of these terms and conditions.

#### **Eligibility to Enter**

2. Entry is open to all residents of Australia.
