Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the Studio 10 | Freedom Kitchens & Inalto Appliances Competition ("Competition") is deemed acceptance of these terms and conditions.

Eligibility to Enter

- 2. Entry is open to residents of NSW, QLD and VIC who own or are purchasing their own home, live within 100km of a Freedom Kitchens Outlet and aged 18 years and above.
