### Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into The Cube | Win \$1000 Competition (“Competition”) is deemed acceptance of these terms and conditions.

#### How to Enter

6. To participate in the Competition entrants must:

Specific details may vary and may include (but not limited to) first name, last name, post code, phone number, email address, gender and date of birth, to become a 10 Play member and submit an entry **and**
  - c. Tell us in 25 words or less what their favourite game from The Cube was from that week’s episode and why?
7. It is free to become a 10 Play member, however, the cost of accessing the promotional website is dependent on the entrant’s individual service provider. These Terms and Conditions apply in conjunction with the 10 Members rules.

## Prize Details
