10 News First Sydney | Sydney Royal Easter Show 2021 Competition Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into 10 News First Sydney | Sydney Royal Easter Show 2021 Competition (“Competition”) is deemed acceptance of these terms and conditions.
2. This is a game of skill and chance plays no factor in determining the winner.

Eligibility to Enter

3. Entry is open to all residents of NSW, aged 18 years and above. How to Enter

6. To participate in the Competition entrants must:
 - a. Watch *10 News First Sydney* nightly from 17:00 on 10 or 10 play during the Competition Period for the nightly code word *and*
 - b. Log on to 10play.com.au/win and register their details in order to submit an entry. Specific details may vary and may include (but not limited to) code word, first name, last name, post code, phone number, email address, gender and date of birth, to become a 10 Play member and submit an entry *and*
 - c. Tell us in 25 words or less what their favourite part of the Sydney Royal Easter Show is and why?

7. It is free to become a 10 Play member, however, the cost of accessing the promotional website is dependent on the entrant's individual service provider. These Terms and Conditions apply in conjunction with the 10 Members rules.
8. Incomprehensible and incomplete entries will be deemed invalid.

16. The Prize Winner/s will be notified by phone call on the day after the judging and/or in writing and the Winner's details will be published on the 10 Play website at 10play.com.au/win within two days after the winner has been fully validated.
17. An entry that is made on behalf of an entrant by a third party will be invalid.

21. Each prize will consist of four (4) x adult tickets that is valid only to an allocated day of the Sydney Royal Easter Show and winners cannot select what day they want to attend.
22. Any ancillary costs associated with redeeming the prizes are not included. These are the responsibility of the Winner/s.
23. All prizes are non-transferrable. No cash alternative is available for any prize. Prizes must be taken as offered. Any prize, unused portion of any prize, or portion of the prize Winner is not entitled to, are not exchangeable or cannot be redeemed as cash. control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a Winner or entrant; or (f) use of the prize.
