Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into Youfoodz | The Bachelor Competition ("Competition") is deemed acceptance of these terms and conditions.

Eligibility to Enter

- 2. Entry is open to all residents of Australia who currently reside in the Youfoodz delivery area.
