Disney's Jungle Cruise | Survivor Competition

Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into Disney's Jungle Cruise | Survivor Competition ("Competition") is deemed acceptance of these terms and conditions.

Eligibility to Enter

2. Entry is open to all residents of Australia. However, employees and the immediate families of Network Ten Pty Limited (the "Promoter"), The Walt Disney Company (Australia) Pty Limited (the "Sponsor") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.
3. Entrants under the age of 16 years must have prior parental consent to enter the Competition.
4. How to Enter

 - b. Register their details. Specific details may vary and may include (but not limited to) first name, last name, post code, phone number, email address, gender, and date of birth, to become a 10 Play member.

Prize is based on full RRP only, if goods are on sale at time of purchase, they will be provided at pre-sale price.
