#### **Terms and Conditions**

- 1. Information on how to enter forms part of the terms of entry. Entry into the The Bachelor | MG Competition ("Competition") is deemed acceptance of these terms and conditions.
- 2. For the avoidance of doubt SAIC Motor Australia Pty Ltd (ACN: 608 096 519) of Suite 1902, Level 19, 100 William Street, Woolloomooloo ("Prize Supplier" or "MG Motor") is not the Promoter of the Competition.

## **Eligibility to Enter**

3. Entry is open to all residents of Australia, 18 years and over and who holds a current, unrestricted, open Australian Driver's Licence.
