# Spotlight | Making It Competition

### **Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into Spotlight | Making It Competition ("Competition") is deemed acceptance of these terms and conditions.

### **Eligibility to Enter**

2. Entry is open to all residents of Australia, aged 18 years and above. However, employees and the immediate families of Network Ten Pty Limited (the "Promoter"), Spotlight Pty Ltd (the "Sponsor") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.

- 4. For clarity each entry period will close and subsequently reopen when the next codeword is announced during the Making It broadcast on Network 10 from 19:30 AEST/AEDT during the competition period.
- 5. The Competition will be advertised on, but not limited to, Network 10 and www.10play.com.au.

#### **How to Enter**

- 6. To participate in the Competition entrants must:
