## Mitsubishi Triton 2021 Competition

#### **Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the Mitsubishi Triton 2021 Competition ("Competition") is deemed acceptance of these terms and conditions.

#### **Eligibility to Enter**

2. Entry is open to all residents of Australia, aged 18 years and over. However, employees and the immediate families of Network Ten Pty Limited (the "Promoter"), Mitsubishi Motors Australia Ltd (the "Sponsor"), Ansible Pty Ltd, and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. #### **How to Enter**
