Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the 10 News First | Paramount + Watch & Win Competition (“**Competition**”) is deemed acceptance of these Terms and Conditions.

Eligibility to Enter

2. Entry is open to all residents of Australia, aged 18 years and above. How to Enter

5. To participate in the Competition entrants must:
 - a. Watch the 10 News First broadcast on Network 10 from 17:00 in their States current time zone, on Monday 26th, Tuesday 27th, Wednesday 28th, Thursday 29th and Friday 30th of September 2022 during the Competition Period to obtain the daily codeword and;
 - b. Log on to 10play.com.au/win and register their details in order to submit an entry. Specific details may vary and may include (but not limited to) codeword, first name, last name, postcode, phone number, email address, gender, and date of birth, to become a 10 Play member and submit an entry.
6. It is free to become a 10 Play member, however, the cost of accessing the promotional website is dependent on the entrant's individual service provider. These Terms and Conditions apply in conjunction with the 10 Members rules.
