# Amaysim HYPBA Competition

### **Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the Amaysim HYPBA Competition ("Competition") is deemed acceptance of these terms and conditions.

### **Eligibility to Enter**

2. Entry is open to all residents of Australia, 18 years and older. However, employees and the immediate families of Network Ten Pty Limited (the "Promoter"), Amaysim Mobile Pty Ltd (the "Sponsor") and their associated agencies and companies or any organisation or individual associated with the provision of the prize are not eligible to enter the Competition. Entrants must be residing in Australia at the time of entry, or their entry may be deemed invalid.

### **How to Enter**
