Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into Perth Zoo x 10 News First Competition ("Competition") is deemed acceptance of these terms and conditions.

Eligibility to Enter

2. Entry is open to all residents of Western Australia, 18 years and older.
