## Lexus Melbourne Cup Ultimate Encore Platinum Experience Competition Terms and Conditions

- 1. Information and instructions on how to enter forms part of these Terms and Conditions. Entry into the Lexus Melbourne Cup Ultimate Encore Platinum Experience Competition ("**Promotion**") is deemed acceptance of these Terms and Conditions.
- 2. Any capitalised terms used in these Terms and Conditions have the meaning given in these Terms and Conditions, unless stated otherwise.

## **Eligibility Criteria**
