## Isuzu UTE | Australian Survivor Watch & Win Competition 2024

### Terms and Conditions

1. Information on how to enter forms part of these Terms and Conditions. Entry into the Isuzu UTE | Australian Survivor Watch & Win Competition (“Competition”) is deemed acceptance of these Terms and Conditions.
2. Any capitalised terms used in these Terms and Conditions have the meaning given in these Terms and Conditions, unless stated otherwise.
3. The promoter is Network Ten Pty Limited (ABN: 91 052 515 250) of 1 Saunders Street, Pyrmont NSW 2009 (“Promoter”).
4. The sponsor is Isuzu UTE Australia (ABN: 80 129 563 739) of 1000 Wynnum Rd, Cannon Hill, QLD, 4170 (“Promoter”).

### Eligibility to Enter

6. Entry is open to all residents of Australia aged 18 years and over who hold a current unrestricted Australian Drivers Licence. However, employees and the immediate families of the Promoter, the Sponsor and their associated agencies and companies or any organisation or individual associated with the provision of the prize are not eligible to enter the Competition. Entrants must be residing in Australia at the time of entry, or their entry may be deemed invalid. “Immediate family member” means spouse, parent, natural or adopted child, and sibling (whether natural or adopted by a parent), whether or not they live in the same household as the director, manager, employee, officer, contractor, associated agency and company or organisation.
7. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.
8. Winner must hold a current unrestricted Australian Driver’s License to be deemed a valid winner. If Winner does not hold a current Australian Driver’s License, their entry will be deemed invalid, and a re-draw will take place.

10. For clarity, each Entry Period will close and subsequently reopen when the next codeword is announced during the Survivor broadcast from 19:30 AEDT during the Competition Period.
11. The Competition will be advertised on, but not limited to, Network 10 and [www.10play.com.au](http://www.10play.com.au).

### **How to Enter**

12. To participate in the Competition entrants must:
  - a. Watch Australian Survivor on Network 10 from 19:30 AEDT on Monday, 5 February 2024, Tuesday, 6 February 2024, Sunday, 11 February 2024, Monday, 12 February 2024, Tuesday, 13 February 2024 and Sunday, 18 February 2024 during the Competition Period to obtain the new codeword and;
  - b. Log on to [10play.com.au/win](http://10play.com.au/win) and register their details in order to submit an entry. Specific details may vary and may include (but not limited to) codeword, first name, last name, postcode, phone number, email address, date of birth, to become a 10 Play member and submit an entry.
13. It is free to become a 10 Play member, however, the cost of accessing the promotional website is dependent on the entrant's individual service provider. These Terms and Conditions apply in conjunction with the 10 Members rules.
14. Codewords will be announced during the broadcast of Australian Survivor on Monday, 5 February 2024, Tuesday, 6 February 2024, Sunday, 11 February 2024, Monday, 12 February 2024, Tuesday, 13 February 2024 and Sunday, 18 February 2024. There will be six (6) codewords in total announced throughout the Competition Period; one (1) codeword corresponding to each registration period stipulated in the table in clause 3. Each codeword will be valid until the next codeword is announced. The last codeword, announced on Sunday, 18 February 2024 will be valid until the Competition closes on Friday, 29 March 2024 at 23:59 AEDT. However, no codeword will be required from Monday, 19 February 2024 as the codeword will be supplied (pre-populated).
15. In the event that the Network 10 broadcast dates are altered, the code words will be aired within the first six (6) episodes only.
16. Codewords will be announced on Network 10 but may not be available on affiliate networks such as WIN and Southern Cross Austereo.

17. Entries will only be considered valid if they meet the requirements of clause 12 and have submitted the correct codeword for the corresponding broadcast period ("Valid Entry"). Any entry submitted with a codeword that has expired, due to a new codeword being announced, will be deemed invalid.
18. Incomprehensible and incomplete entries will be deemed invalid.

24. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions will be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
25. In consideration for the Promoter awarding the prize to the winner of the Competition ("Major Prize Winner"), the winner hereby permits their image and/or voice, as recorded, photographed, or filmed during the winner's participation in the prize to appear in connection with Network 10 or the Sponsor or the advertising and/or marketing thereof, in any media whatsoever through the world and the Major Prize Winner will not be entitled to any fee for such use.

## **Draw Details**

**Notification of Winner**

27. The Major Prize Winner will be notified by a phone call within two (2) days of the draw and in writing and the Major Prize Winner’s details will be published on the 10 Play website at 10play.com.au from Wednesday, 3 April 2024.
28. An entry that is made on behalf of an entrant by a third party will be invalid.

37. 39. Final timings will be stipulated by the Sponsor.
40. The Major Prize Winner must make their own way to the appointed Sponsor Dealership, and costs associated with travel to and or from the Sponsor Dealership are to be borne by the Major Prize Winner.
41. If the Major Prize is unavailable, for whatever reason, the Promoter and Sponsor reserves the right to substitute the Major Prize for a prize of equal or less value, subject to any directions given under State Regulation.
42. Neither the Promoter nor the Sponsor is responsible nor liable for any damaged, delayed or lost in transit in the delivery of the prizes.
43. The Promoter's decision is final, and the Promoter will not enter into correspondence regarding the Competition result.
44. It is a condition of accepting the Major Prize that the Major Prize Winner must comply with all the conditions of use of the Major Prize and the Sponsor's requirements.
45. In the event that for any reason whatsoever the Major Prize Winner does not take an element of the Major Prize at the time stipulated by the Promoter then that element of the Major Prize will be forfeited by the Major Prize Winner and cash will not be awarded in lieu of that element of the Major Prize.

50. By accepting the Major Prize, the Major Prize Winner agrees to participate in and co-operate as required with all reasonable media editorial requests relating to the Major

Prize, including but not limited to, being interviewed, and photographed, filmed and/or chaperoned throughout the duration of accepting the Major Prize.

51. If for any reason this Competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Competition, subject to government legislation.
52. If an entry is selected as a winning entry, validation of your circumstances and the validity of your entry will be undertaken by the Promoter. Method of validation (without limitation) will be determined by the Promoter at its complete discretion. If the winning entry is deemed to be a Major Prize Winner, they will be notified in accordance with these terms and conditions. In the event that the Promoter requests the entrant to sign any legal documents relating to the verification of their medical circumstance, the legal documents will take the form determined by the Promoter. It is a condition of accepting the Major Prize the Major Prize Winner signs any such legal documentation.
53. Nothing in these terms and conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Sponsor (including their respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion and: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a Winner or entrant; or (f) use of the prize.
54. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate, subject to government legislation.
55. All entries become the property of the Promoter.
56. The Promoter and the Sponsor shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any

personal injury suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law. The Promoter and the Sponsor are not responsible for any incorrect or inaccurate information, either caused by the phone user or for any of the equipment or programming associated with or utilised in this Competition, or for any technical error, or any combination thereof that may occur in the course of the administration of this Competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.

You consent to the Promoter collecting your personal information for the purpose of conducting and promoting this Competition (including but not limited to determining and notifying the Major Prize Winner and the Major Prize fulfilment).
