## ANZ | Shark Tank Competition

### Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into ANZ | Shark Tank Competition (“Competition”) is deemed acceptance of these terms and conditions.

#### Eligibility to Enter

2. Entry is open to all residents of Australia, 18 years and older. However, employees and the immediate families of Network Ten Pty Limited (the “Promoter”), Australia and New Zealand Banking Group Limited (ANZ) ABN 11 005 357 522 (the “Sponsor”) and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.

#### Competition Period

3. The Competition commences on **Wednesday, 16 October 2024 at 18:00 AEDT** and closes on **Thursday, 12 December 2024 at 23:59 AEDT** (“Competition Period”).

#### How to Enter

5. To participate in the Competition entrants must:
  - a. Log on to [10play.com.au](http://10play.com.au) and register their details including (but not limited to) name, address, phone number, email address, gender, and date of birth, to become a 10 Play member, and;
  - b. Complete the 3-question online ANZ Quiz (“Quiz”).
6. For clarity, the entrant’s Quiz result has no impact on their chance of winning. All entrants who enter in accordance with clause 5 will be entered into the prize draw, regardless of their Quiz result.
7. It is free to become a 10 Play member, however, the cost of accessing the promotional website is dependent on the entrant’s individual service provider. 8. Incomprehensible and incomplete entries will be deemed invalid.

In consideration for the Promoter awarding the prize to the Major Prize Winner ("Winner"), the Winner hereby permits the Winner's image and/or voice, as recorded, photographed or filmed during the Winner's participation in the prize to appear in connection with Network 10 or the Sponsor or the advertising or marketing thereof, in any media whatsoever through the world and the Winner will not be entitled to any fee for such use.

18. An entry that is made on behalf of an entrant by a third party will be invalid.

21. The total Prize Pool is valued at **\$10,000.00**.
22. The Prize will only be paid via EFT to the Winner's nominated bank account by Ansible Ptd Ltd. The Prize must be taken as offered. The Prize value is in Australian dollars. The Promoter nor Sponsor does not take any responsibility for any tax consequences or imposts that arise from the receipt of the Prize.
23. Any ancillary costs associated with redeeming the prizes are not included. These are the responsibility of the Winner.
24. All prizes are non-transferrable. The Winner is advised that tax implications may arise from their prize winnings, and they should seek independent financial advice prior to acceptance of their prize.

26. 27. The Promoter's decision is final, and the Promoter will not enter into correspondence regarding the Competition result.

Nothing in these Terms and Conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Sponsor (including their respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion and: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a Winner or entrant; or (f) use of the prize.

If this competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate, subject to government legislation.
40. All entries become the property of the Promoter.
41. The Promoter and the Sponsor shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury

suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law. The Promoter is not responsible for any incorrect or inaccurate information, either caused by the phone user or for any of the equipment or programming associated with or utilised in this Competition, or for any technical error, or any combination thereof that may occur in the course of the administration of this Competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.

You consent to The Promoter collecting your personal information for the purpose of conducting and promoting this Competition (including but not limited to determining and notifying the Winner and prize fulfilment). Your personal information may be disclosed to a third party as a result of entering this Competition, including but not limited to the Sponsor and Ansible Pty Ltd.
