## Celebrity Guess Who? Competition

### Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into Celebrity Guess Who? Competition ("**Competition**") is deemed acceptance of these Terms and Conditions.
2. Any capitalised terms used in these Terms and Conditions have the meaning given in these Terms and Conditions, unless stated otherwise.
3. The promoter is Network Ten Pty Limited (ABN: 91 052 515 250) of 1 Saunders Street, Pyrmont NSW 2009 ("Promoter").
4. Permit Approvals: ACT: TP 24/02998, NSW Authority: TP/00146, SA: T24/2274

### Eligibility to Enter

5. Entry is open to all residents of Australia aged 18 years and older. However, employees and the immediate families of the Promoter and their associated agencies and companies or any organisation or individual associated with the provision of the prize are not eligible to enter the Competition. Entrants must be residing in Australia at the time of entry, or their entry may be deemed invalid. "Immediate family member" means spouse, parent, natural or adopted child, and sibling (whether natural or adopted by a parent), whether or not they live in the same household as the director, manager, employee, officer, contractor, associated agency and company or organisation.
6. If the Major Prize Winner is unable to complete the prize travel as stipulated in clause 28, they will forfeit the prize in full and a re-draw will take place as specified in these terms and conditions.
7. Entrants must correctly guess, with accurate spelling, at least one celebrity with the given clue, to be an eligible participant in the prize draw. Each celebrity guessed correctly throughout the Competition Period, will grant the entrant one entry into the prize draw.

### Competition Period

8. The Competition commences on **Monday, 23 December 2024 at 12:00 AEDT** and closes on **Monday, 20 January 2025 at 19:30 AEDT** ("**Competition Period**").
9. The Competition will be advertised on, but not limited to, Network 10, Network 10's Facebook Page and [www.10play.com.au](http://www.10play.com.au).

### How to Enter

10. To participate in the Competition entrants must:
  - a. Watch the 2025 season of I'm A Celebrity...Get Me Out Of Here! promotional teaser television commercials on Network 10 or check the competition entry page and Network 10's associated social channels throughout the duration of the promotion for the

- celebrity clues on who will be entering I'm a Celebrity...Get Me Out of Here, the television series on Network 10; and
- b. Log on during the Competition Period to [10play.com.au/win](http://10play.com.au/win) and register their celebrity guess/es in order to submit a valid entry. Entrants must correctly guess the first name and the last name of the celebrity or as directed by the Promoter on the entry form at the time of entry. Specific registration details may vary and may include (but not be limited to) entrants first name, last name, postcode, phone number, email address, gender, and date of birth, to become a 10 Play member and submit an entry.
11. To clarify, in order to enter the competition, entrants must correctly guess and correctly spell the name/s of a celebrity who will be appearing in 2025 I'm a Celebrity...Get Me Out of here television series on Network 10, submitting their guess/es individually, throughout the competition period. The option to guess more than one celebrity at a time may be available throughout the promotional period with the number of celebrity guesses (i.e. entries) available each day changing at the Promoters discretion. Each celebrity guessed correctly throughout the Competition Period by the entrant, will grant them one entry into the prize draw.

Clues can be used to guess the celebrities being revealed. The Competition page will be updated regularly to reflect any new celebrity clues throughout the competition period, for entrants to guess that celebrity. Once a celebrity has been revealed or announced, the ability to enter that celebrities name may be closed off from the Competition page and entrants may no longer be able to guess that celebrity. The closing date and time of each celebrity entry phase is at the discretion of the Promoter.
  14. Clues will be announced on Network 10 but may not be available on affiliate networks such as WIN and Southern Cross Austereo.
  15. Entries will only be considered valid if they meet the requirements of clause 10, have submitted a correct celebrity and have the spelling of the celebrity correct ("**Valid Entry**").
  16. Incomprehensible and incomplete entries will be deemed invalid.
  17. Entrants who have won a major prize in any Network 10 Competition in the past 12 months are not eligible to win the prize in this Competition, excluding SA who are eligible to win more than once.

29. The total Prize Pool is valued at AUD **Up to \$37,500.00** (including GST). The Promoter accepts no responsibility for change in prize value between now the ultimate prize redemption date.

48. Any necessary visas, vaccinations, COVID-19 tests, passports and any associated costs are the responsibility of the Major Prize Winner and their travelling companion.
